



TRIP/BAND FINANCIAL CONTRIBUTION CONTRACT & PAYMENT SCHEUDLE

San Antonio, Texas Trip
March 29 – March 31, 2019

Purpose	To give the Clark High School Band students the opportunity to perform in the Director's Choice Music Festival contest for a panel of adjudicators. Students will also experience the atmosphere of San Antonio. (Students will miss classes with an excused absence. Students will be responsible for all class work missed).
Participation	CHS band students may participate if they are academically eligible to participate in UIL concert and sight-reading contest, are in good standing within the band program and Clark High School, and have met the financial obligations for the trip.
Supervision	Students will be supervised by a CHS administrator, the band directors, and parent chaperones as per PISD guidelines. Students not abiding by rules and regulations established by PISD, CHS, and the CHS Band will have restricted activities on the trip or will be sent home at the parent's expense.
Travel	Included in the trip price will be travel to/from Clark High School and San Antonio via charter bus.
Housing	Included in the trip cost will be two nights' stay at a hotel in San Antonio. A curfew will be implemented and enforced. Rooming lists must be submitted by February 2019.
Activities	Included in the trip cost will be admission to Six Flags Fiesta Texas, buffet and games at Dave & Busters, and Natural Bridge Caverns.
Performances	The Clark High School Varsity Band, Concert Band, Symphonic Band and Wind Ensemble will perform in the Director's Choice contest, Showcase of Music at the Lila Cockrell Theater in San Antonio. Registration and contest fees are included in student trip costs.
Meals	Included in the trip cost will be 2 days' breakfast at the hotel, and 1 meal at Dave & Busters.
Eligibility	Students must be academically eligible to participate in the trip. The 3 rd Nine Weeks grading period (ends on March 8, 2019) will determine whether a student is eligible or ineligible for the band trip. If a student is failing one or more classes at the end of the 3 rd Nine Weeks he/she will become ineligible on March 22, 2018.
Trip Cost	The total trip cost is \$450.00 including all items listed above.
Payment Schedule	Because of payment deadlines for charter buses, lodging, and other costs the following payment schedule must be followed. If special arrangements are needed, please contact Laura Sturch, Director of Bands. Payment of funds may be paid directly by personal check or may be fundraised by payment dates. Payment in full for trip and contribution will be accepted at any time. Failure to follow this schedule and meet trip payment deadlines may result in the cancellation of your trip reservation.

Refunds No refunds will be possible after the first deposit payment is made. The Clark High School Band will be committed by contract to Director's Choice Travel for all student trip costs. Refunds cannot be made for academic ineligibility, illness, or other factors beyond our control. No fundraised monies can be refunded per PISD policy. Transferring of funds between students is prohibited.
